## **Sustaining Improvement Inspection of Castledawson Primary School, Castledawson, County Londonderry (301-3704)**

### **Introduction**

The previous inspection in April 2016 evaluated the overall effectiveness of Castledawson Primary School as having a high level of capacity for sustained improvement. The school participates in a well-established shared education partnership with a local maintained primary school. A sustaining improvement inspection (SII) was conducted on 9 May 2019.

Four of the teaching unions which make up the Northern Ireland Teachers' Council (NITC) have declared industrial action primarily in relation to a pay dispute. This includes non-co-operation with the Education and Training Inspectorate (ETI). Prior to the inspection, the school informed the ETI that none of the teachers would be co-operating with the inspectors. The principal co-operated with the inspection team in relation to safeguarding responsibilities. The ETI has a statutory duty to monitor, inspect and report on the quality of education under Article 102 of the Education and Libraries (Northern Ireland) Order 1986. Therefore, the inspection proceeded and the following evaluations are based on the evidence as made available at the time of the inspection.

### **Focus of the inspection**

Owing to the school's participation in industrial action:

- the inspection was unable to focus on evaluating the extent to which the school is capable of demonstrating its capacity to effect improvement through self-evaluation and effective school planning; and
- a line of inquiry was not selected by the school from the development plan priorities.

### **Key findings**

- In discussion with a group of year 6 children, they report that they have very good opportunities to develop their leadership capabilities through the 'digital leaders' and 'playground pals' schemes, and through their roles in the School- and Eco-Councils. They stated that they enjoy participating in the wide range of extra- and co-curricular activities afforded to them.

The ETI was unable to evaluate fully:

- the line of inquiry; and
- the quality of learning and teaching within the classrooms.

### **Safeguarding**

During the inspection, the school provided evidence that the arrangements for safeguarding children reflect broadly the guidance from the Department of Education. In discussions with a group of year 6 children, they reported that they feel safe in school and know who to talk to if they have any concerns about their safety or well-being. They also stated that they know how to stay safe online in school and at home. However, owing to the action short of strike, the ETI was unable to evaluate fully the outworking of the arrangements for safeguarding in the school.

## **Conclusion**

Owing to the impact of the action short of strike being taken by the staff, the ETI is unable to assure parents/carers, the wider school community and stakeholders of the quality of education being provided for the children. The school is a high priority for future inspection with no further notice.
