1. Introduction

Naíscoil Léim an Mhadaidh opened in December 2008; it is situated in the grounds of Gaelscoil Léim an Mhadaidh, in Limavady, County Derry. A new leader and a new assistant were appointed in 2010.

2. Inspection methods and evidence base

The inspection evaluations are based on evidence gained from in-class observations and from a range of documentation provided by the naíscoil.

The views of the parents, staff, and management group were sought through a confidential questionnaire prior to the inspection. Twelve questionnaires were issued to the parents and ten were returned with five additional written comments. All of the staff and four members of the management group also returned the questionnaires with written comments. All of the returns from the questionnaires indicated high levels of satisfaction with the work of the naíscoil. The reporting inspector shared the responses from the questionnaires with the staff and the members of the management group who attended the oral report back.

3. Overall finding of the inspection

In the areas inspected the quality of education provided by the naíscoil is good; the naíscoil has important strengths in most of its educational and pastoral provision. The inspection has identified an area for improvement in the provision for learning which the naíscoil has demonstrated the capacity to address. The inspectorate will monitor the naíscoil's progress on the area for improvement.

KEY FINDINGS OF THE INSPECTION

4. Children's Achievements

The quality of the children's achievements is good.

- The children are very well-settled for the time of year and are developing positive attitudes to their learning.
- The children show a good understanding of the Irish spoken to them by the staff.
- During the inspection, almost all of the children engaged in purposeful play; they showed high levels of concentration and independence and they co-operated well with one another and with the adults.
- The children demonstrate a keen interest in books and in experimenting with early writing.

5. Provision for Learning

The quality of the provision for learning is good.

- The quality of the arrangements for pastoral care in the naíscoil is very good. The staff know the children well; they demonstrate commitment to both the care and well-being of the children and to the promotion of their independence and self-management skills. The positive relationships at all levels foster an inclusive and supportive ethos in the naíscoil.
- The staff have worked hard to create a bright, clean and stimulating learning environment for the children. The children's work is valued and presented around the playroom in an attractive manner.
- The staff have developed a thorough and comprehensive approach to planning, to observing the children at play and to recording their responses. The staff now need to make better use of the observations and the daily evaluations to inform further their planning, in order to meet the differing needs of the children.
- The children are provided with a healthy snack and have regular access to drinking water. They engage in a range of well-planned physical activities, both indoors and outdoors.
- The staff work hard to create a strong immersion environment which supports effectively the children's acquisition of the Irish language. The quality of the staff's spoken Irish during the inspection was generally good; the staff are currently developing their competence in the Irish language.
- On the basis of the evidence available at the time of the inspection the naíscoil has comprehensive arrangements in place for safeguarding children. These arrangements reflect the guidance issued by the Department of Education.

6. Leadership and Management

The quality of leadership and management is very good.

- The staff are developing well a culture of self-evaluation leading to improvement. They evaluate the provision regularly and have identified key priorities for improvement.
- The naíscoil staff have the support of an early years' specialist (EYS) from ALTRAM. The EYS has provided very good, focused advice to the group and is supporting them well with the ongoing improvement of their provision within the naíscoil.

CONCLUSION

In the areas inspected, the quality of education provided by the naíscoil is good; the naíscoil has important strengths in most of its educational and pastoral provision. The inspection has identified an area for improvement in the provision for learning which the naíscoil has demonstrated the capacity to address.

The area for improvement is:

- the need for the staff to make better use of the observations and evaluations to inform further their planning in order to meet the differing needs of all the children.

The Education and Training Inspectorate will monitor the naíscóil's progress in addressing the area for improvement.
