

#### **INTRODUCTION**

#### 1. Context

Sandbrook Nursery School is a controlled nursery situated in east Belfast. The nursery comprises two full-time classes in purpose-built accommodation. At the time of the inspection the two assistant teachers were sharing the role of acting principal, in the absence of the principal. Three governors had recently resigned.

Four of the teaching unions which make up the Northern Ireland Teachers' Council (NITC) have declared strike action/Action Short of Strike (ASoS) in relation to a pay dispute. This includes non-co-operation with the ETI. Prior to the inspection, the nursery informed the ETI that the principal and the assistant teacher would not be co-operating with the inspectors. The ETI have a statutory duty to monitor, inspect and report on the quality of education under Article 102 of the Education and Libraries (Northern Ireland) Order 1986. Therefore, the inspection proceeded and the following evaluations are based on the evidence available at the time of the inspection.

- the outcomes for learners;
- the quality of the provision; and
- leadership and management.

#### **KEY FINDINGS**

#### 5. Outcomes for learners

The ETI was unable to evaluate:

- the standards attained by the children;
- progression in the children's learning; and
- the children's wider skills and dispositions.

#### 6. Quality of provision

The ETI was unable to evaluate:

- the quality of the curriculum (including breadth, balance and appropriateness);
- the effectiveness of the guidance and support in bringing about high quality individual learning experiences;
- the effectiveness and impact of planning, teaching, learning and assessment in promoting successful learning; and
- care and welfare.

#### 7. Leadership and management

The ETI was unable to evaluate:

- the effectiveness of strategic leadership and governance;
- the effectiveness and impact of middle leadership; and
- the effectiveness of action to promote and sustain improvement (including selfevaluation and the development planning process).

The school did not provide evidence that satisfactory arrangements are in place for safeguarding learners.

Owing to the action short of strike, the ETI was unable to evaluate fully the outworking of the arrangements for safeguarding in the school. However, based on the evidence available at the time of the inspection (and noting that work is underway on addressing the following issues), the areas that require urgent improvement include:

- update training for all governors on child-protection and safeguarding;
- the review and revision of key policies which are out of date; and
- the governors to complete the review of child-protection and safeguarding policy and practice.

#### CONCLUSION

#### 8. Overall effectiveness

Owing to the impact of the action short of strike being taken by the acting-principals, the ETI is unable to assure parents/carers, the wider school community and stakeholders of the quality of education and safeguarding being provided for the children. The nursery is a high priority for future inspection with no further notification.

The ETI will return to the nursery within six weeks to evaluate and report on the arrangements for safeguarding.

# ADDENDUM TO THE REPORT ON THE INSPECTION OF SANDBROOK NURSERY SCHOOL IN APRIL 2017

#### **SAFEGUARDING**

The ETI returned to the nursery on 16 June 2017 to monitor and report on arrangements for safeguarding.

The purpose of the visit was to provide the nursery with a further opportunity to provide evidence on its arrangements for safeguarding; owing to action short of strike, the nursery did not provide evidence that satisfactory arrangements were in place at the time of the original inspection on 3 April 2017.

Owing to the ongoing action short of strike, the ETI was unable to evaluate fully the outworking of the arrangements for safeguarding in the nursery.

During the follow-up visit, the nursery provided evidence that satisfactory arrangements for safeguarding reflect broadly the guidance issued by the relevant Departments. Work on the following aspects is underway and needs to be completed:

• the draft policies for Anti-bullying, Positive Behaviour and Health and Safety need to be finalised and ratified by the governors.
