

# **Sustaining Improvement Inspection of Ballymoney Model Controlled Integrated Primary School, County Antrim (305-0866)**

## **Introduction**

The previous inspection in May 2015, evaluated the overall effectiveness of Ballymoney Model Controlled Integrated Primary School as good<sup>1</sup>. A sustaining improvement inspection (SII) was conducted on 31 May 2018.

Four of the teaching unions which make up the Northern Ireland Teachers' Council (NITC) have declared industrial action primarily in relation to a pay dispute. This includes non-co-operation with the Education and Training Inspectorate (ETI). Prior to the inspection, the school informed the ETI that all of the teachers, including the principal, would not be co-operating with the inspectors. The ETI has a statutory duty to monitor, inspect and report on the quality of education under Article 102 of the Education and Libraries (Northern Ireland) Order 1986. Therefore, the inspection proceeded and the following evaluations are based on the evidence as made available at the time of the inspection.

## **Focus of the inspection**

Owing to the school's participation in industrial action:

- the inspection was unable to focus on evaluating the extent to which the school is capable of demonstrating its capacity to effect improvement through self-evaluation and effective school planning; and
- lines of inquiry were not selected by the school from the development plan priorities.

## **Key findings**

The ETI was unable to evaluate:

- the lines of inquiry; and
- the quality of learning and teaching within the classrooms.

## **Safeguarding**

- During the inspection, the school did not provide evidence that the arrangements for safeguarding children reflect or reflect broadly the guidance from the Department of Education.<sup>2</sup>

## **Conclusion**

Owing to the impact of the action short of strike being taken by the staff, the ETI is unable to assure parents/carers, the wider school community and stakeholders of the quality of education and safeguarding being provided for the children. The school is a high priority for future inspection with no further notice.

The ETI will return to the school within six weeks to evaluate the progress in addressing the arrangements for safeguarding.

## **ADDENDUM TO THE REPORT ON THE INSPECTION OF BALLYMONEY MODEL CONTROLLED INTEGRATED PRIMARY SCHOOL, CO ANTRIM, IN MAY 2018**

### **SAFEGUARDING**

The ETI returned to the school on 11 September 2018 to monitor and report on arrangements for safeguarding.

The purpose of the visit was to provide the school with a further opportunity to provide evidence on its arrangements for safeguarding. Owing to action short of strike, the school did not provide evidence that the arrangements for safeguarding children reflect or reflect broadly the guidance from the Department of Education at the time of the inspection on 31 May 2018.

During the follow-up visit, the school provided evidence that the arrangements for safeguarding children reflect broadly the guidance from the Department of Education.

In discussion with the year 6 children, they reported that they feel safe in school and know what to do and who to talk to if they are concerned about their safety or well-being. However, owing to the action short of strike, the ETI was unable to evaluate fully the outworking of the arrangements for safeguarding in the school.

### **Health and safety**
