Consultation on the delivery of remote learning in Education Other Than At School (EOTAS)

February 2021

A full report for EOTAS centres, building on the quantitative analysis and containing analysis of the qualitative findings from the consultation, in-depth case studies on remote learning and centres' monitoring of the delivery and quality of remote learning, will follow in March 2021. The qualitative analysis will include the additional written feedback from the consultation about approaches/strategies, including those used for:

- mental health and well-being;
- aspects that are working well with remote learning;
- provision of feedback to pupils when learning remotely; and
- when pupils do not register or log-on.

The report will also include feedback on the barriers to pupil engagement with remote learning.
