1. The centre is located in a mobile in the grounds of St Mary's Primary School. The children come mainly from the immediate and surrounding area.

2. The parents, staff and management group were given opportunities to express their views about the centre through the inspection questionnaires. The responses have been taken into account as part of the inspection. In their responses, nearly all of the parents were satisfied or very satisfied with all aspects of the centre's provision. Some of the parents added written comments which highlighted the positive ethos of the centre and the hard work of the staff.

3. The quality of the arrangements for pastoral care and child protection in the centre is very good. The centre has procedures in place which implement fully the guidance outlined in the relevant Department of Education (DE) Circulars.

4. The school's programme for the promotion of health and well-being has strengths, with a developing commitment to encourage the children to eat healthily and be physically active.

**5. The main strengths within the centre's educational and pastoral provision are as follows.**

- The positive ethos helps to promote a settled, caring atmosphere and very good relationships at all levels. The staff make very good use of the available space and create an attractive and stimulating learning environment which is enhanced by examples of the children's art work.
- There are good opportunities for learning in most aspects of the pre-school curriculum. There are particular strengths in the promotion of the children's personal, social and emotional development, raising mathematical awareness and the attention given to developing the children's creative ideas.
- The staff interact with the children in a supportive manner and the quality of the interaction is consistently of a high standard.
- The good start made to planning a varied and interesting programme and the detailed methods of assessment that take account of the children's responses to the play activities and help to ensure the needs of all the children are well met.
- The centre has established very good links with the parents and the neighbouring primary school.
- The leader is dedicated and provides effective leadership for the hard-working staff who work very well as a team.

**6. The inspection identified areas for improvement. The following are the most important areas that need attention.**

- The staff need to develop aspects of the physical play programme in order to ensure more challenge and progression in the activities throughout the year.
- The written planning needs to identify more clearly the learning to be promoted in the planned activities.

**7.** The staff implement a useful method of self-evaluation. Appropriate areas have been identified for development. Progress has been made in developing the links with the parents, and helping to ensure a smooth transition for the children between home and the centre. The early years specialist has made a very good contribution to the overall development of the provision in this pre-school centre. The support provided is well focused.

**8.** The pre-school centre has important strengths in most of its educational and pastoral provision. The inspection has identified minor areas for improvement which the pre-school centre has the capacity to address.

The pre-school centre's progress on the areas for improvement will be followed-up by monitoring visits conducted by the District Inspector.

### **HEALTH AND SAFETY**

- At the time of the inspection, it was noted that the entrance door to the main primary school building, which is used by the playgroup to access the toilet area, was not always secured.
