

1. Inspection method and evidence base

The key questions and quality indicators which guide inspection and self-evaluation of pre-school settings, which were applied to this inspection, are available in the ETI publication *Together Towards Improvement: a process for self-evaluation* at: <u>Together Towards Improvement Pre-school | Education and Training Inspectorate</u>

Inspectors observed learning and teaching through play, the children's achievements and standards, scrutinised relevant documentation, and held formal and informal discussions with children, and staff with specific responsibilities.

The arrangements for this inspection included:

- a discussion with the staff;
- a meeting with those involved with leadership and management including the management group; and
- the opportunity for the parents and staff to complete a confidential questionnaire.

A small number of parents and all of the staff completed the online confidential questionnaires. The parental responses indicated high levels of satisfaction with the provision. In particular, the parents highlighted the helpful and friendly staff and the progress of the children. The staff responses were wholly positive, highlighting the important role of the playgroup within the local community.

2. Focus of inspection

In order to promote improvement in the interest of all children, the purpose of inspection is, through effective linking of internal and external approaches, to evaluate the:

- children's achievements and standards;
- quality of provision for learning; and
- quality of leadership and management.

3. Context

Keady Community Playgroup is situated in purpose-built accommodation in Keady village. All of the staff have been in post since the last inspection. The playgroup has recently had a change of early years specialist (EYS) from the Early Years Organisation. The staff operate a HighScope programme.

5. Achievements and standards

- Almost all of the children are well-settled for the time of year. They collaborate
 well during play and are polite and respectful in their engagement with adults and
 one another. The children demonstrate high levels of independence when
 choosing activities, tidying up resources and managing their snack routine.
 Overall, the children display a very positive attitude to learning.
- Most of the children are confident in their interaction with adults. They are attentive during the group story session and have a good interest in books. Most of the children access an appropriate range of writing tools and materials and are developing well their pre-writing skills through planning and reviewing their play activities.
- During the inspection, the children were observed engaging in early mathematical activities and are developing an appropriate understanding of shape, number, sorting and pattern. The children need more opportunities to develop their creativity in the arts both indoors and outdoors.

6. Provision for learning

- The staff have worked diligently to provide an attractive and child-centred learning environment. They make very good use of daily routines to develop the children's personal skills and promote social responsibility in caring for their environment.
- On the day of inspection, the staff interactions were consistently good and, on a significant minority of the occasions, very good. In the best practice observed, the adults responded effectively to the children's interests and ideas and used skilful questioning to promote their thinking.
- The planning demonstrates that the children have good opportunities for learning in most areas of the curriculum. The staff have established recently an outdoor garden which provides the children with good opportunities to grow vegetables and plants, promoting further their interest in the natural environment. In going forward, it will be important for the staff to develop the planning for outdoor play to ensure that the children have appropriate opportunities to develop their learning across all areas of the curriculum.
- The staff know the children very well and record insightful observations to assess the children's progress. The children who have additional needs are supported appropriately by the staff.
- The quality of the arrangements for pastoral care in the nursery school is very good. A welcoming ethos pervades the playgroup and very positive working relationships are evident at all levels. All staff are fully committed and dedicated to the children in their care.
- The staff give very good attention to promoting healthy eating through the promotion of healthy foods in the snack routine, baking activities and growing fruits and vegetables in the raised garden beds outdoors. The regular outdoor play sessions provide good opportunities for the children to engage in physical activity.

7. Leadership and management

- The experienced staff work effectively and collaboratively as a team. The staff, working in partnership with the members of the management committee, are fully committed to the best outcomes for the children and the families in the area.
- The playgroup's development planning processes are at an early stage of development. While the development plan outlines a number of priorities for future improvement, there is a need for the staff, with the support of the newly appointed EYS, to monitor and evaluate the impact of their work in improving the learning experiences of the children.
- There are good links with the parents who are kept well informed about events within the playgroup through the parents' information board, the informative newsletters and numerous parent meetings. The staff have also developed good links with local primary schools.
- On the basis of the evidence available at the time of the inspection, the playgroup has satisfactory arrangements in place for safeguarding children. These arrangements broadly reflect the guidance issued by the relevant Departments. The following areas need to be addressed:
 - the member of the management committee with responsibility for child protection needs updated training; and
 - the chair of the management committee needs to sign the record book regarding complaints on an annual basis.

8. Overall effectiveness

Keady Community Playgroup needs to address an important area for improvement in the interest of all the learners. The ETI will monitor and report on the playgroup's progress in addressing the area for improvement which includes the need to:

• develop the process of self-evaluation and development planning in order to bring about further improvement to the arts and outdoor play provision.

There will be a formal follow-up inspection in 12 to 18 months.
